About the State of Massachusetts Guidelines

Massachusetts COVID-19 Order No. 13, revised and extended on March 31, 2020 establishes new health and safety compliance requirements for public works sites and guidelines for towns and cities, who are empowered to apply these requirements to all construction sites.

GZA services to help you meet COVID-19 Construction Safety Guidance Requirements

- **Planning:** GZA's team of EHS Professionals, Regulatory Specialists, and Public Health Experts will prepare project Health and Safety Plans (HASPs) and Contingency Response Plans on behalf of the Project Owner and Site-Specific Risk Analyses and supplemental COVID-19 safety plans on behalf of cities and towns.
- **Training and Education:** GZA will provide State-conformant, critical training and Health & Safety resource information to all project stakeholders.
- **Compliance:** GZA EHS Professionals can serve as project Health and Safety and/or COVID-19 Officer to establish and document compliance including: self-certification; monitoring and enforcement of hygiene and social distancing measures; monitoring and enforcement of work site prevention practices, and daily reporting.
- **Oversight and Enforcement:** GZA serves as third-party private inspectors on behalf of cities and towns, including site-specific risk analysis, review of HASPs and Safety Plans, site inspections, documentation, and project shutdown advisory services.



Related GZA Services

Related GZA services include:

- **COVID-19 Sanitation Processes:** GZA provides and manages cleaning and decontamination services for project offices and high contact surfaces. GZA also provides third-party evaluation of cleaning companies hired directly by owners by reviewing their cleaning products, means and methods, and health and safety protocols.
