RISK AND RESILIENCY ASSESSMENT EMERGENCY RESPONSE PLAN UPDATE



Infrastructure Act of 2018 requires that community (drinking) water systems

serving more than 3,300 people to develop or update risk assessments and emergency response plans (ERPs). Deadlines for certifying completion range from March 2020 to December 2021, depending on system size. Assessment include risk and resilience of water system components, monitoring practices, financial capabilities, operational and maintenance practices. Comprehensive evaluation of threat categories and probabilities is required to assess risk of and resilience to malevolent acts. GZA utilizes its own GIS tools and those provided by USEPA, National Weather Service, AWWA and others to assure that your risk and resilience assessments and emergency response plans that meet the specific requirements outlined under AWIA Section 2013.
