## Step-by-Step Registration Guide

Whether you are a current or new GZA vendor, here is a step-by-step guide to help you get started registering on the GZA Supplier Portal:

1. Access the Portal: Visit the GZA Supplier Portal at <https://supplier.gza.com/>
2. Create an Account: Click on the 'Create new account' button and fill out the required fields to create a new account.
3. Verify Email: After registration, you will receive a verification email. Click on the link provided to verify your email address. If you do not receive this email within a few minutes, check your spam folders.
4. Complete Profile: Log in to the portal with the credentials you established and complete your vendor profile by providing all necessary information, including company details, certifications, and financial data.
5. Submit Documentation: Upload required documents such as W-9 forms, certifications, insurance certificates, and other requested documentation.
6. Review and Submit: Review your information for accuracy and submit your profile for approval.

For vendors required to submit a certificate of insurance (COI), it is important to note the following on your COI to enable streamlined payment to your firm. The COI you submit to the Portal is in addition to project-specific COIs that may be requested by your GZA Project Manager.

1. GZA minimum insurance requirements are communicated when you complete the insurance section of your profile. Coverage amounts evidenced on the submitted COI should match those minimum coverage amounts.
2. GZA and GZA's Client must be added as 'Additional Insureds (for ongoing and completed operations) on a primary and non-contributory basis for all policies except workers compensation and professional liability, where required by written contract.
3. All policies must provide a Waiver of Subrogation in favor of the Additional Insureds, where required by written contract.
